11:07 - New Nee-Ke-Wa Chapter Chiefs

Amending bylaws to include co-chiefs in all positions.

Questions regarding the length and effectiveness of double chiefs have to be looked at. Jacob W. Asks: How can we ensure that the two chiefs aren't 'slacking off'? Would we remove one chief and replace them, or would it be one chief alone? Stephanie Asks: Would the other positions (co-chiefs) be as effective with assistants compared to just having committee members? Brady responds: You're going to have a lot of wiggle areas with co-VCs. You still need the basic organizational structure, i.e., with Admin, we have a very structured bureaucratic process. For every instance that you want co-chiefs, do it on a case-by-case basis.

Amending bylaws to extend the original Co-Chief amendment to include all Lodge positions.

Proposal: yearly budget taken out of Lodge budget for chapter meetings/activities. \$300 per chapter, 10 meetings per year. Money would be distributed equally. Money would be given on a case-by-case basis, not handing the CCs a blank check. CC purchases the equipment, then is reimbursed by the lodge afterwards. It would be \$1500 a year. Chapters could fundraise at Blue and Golds using the seed money provided. A formal proposal is needed soon for a proper vote.
