

FourCorps 2010

In conjunction with the United States Forest Service, Section S-4 hosts the groundbreaking "FourCorps 2010" in the Ocala National Forest. Modeled after ArrowCorps5, FourCorps 2010 will be a week of service and fellowship.

The current priority list of projects is as follows: blocking off several illegal roads by planting trees at the road way entrances, thinning (removing) pine trees that are too close to each other to successfully grow, removing invasive species/clearing a section of the forests perimeter, planting natural vegetation to restore a lake's surrounding area, building bear boxes for a family campground, building kestrel boxes, and lastly, removing an invasive species from a fresh water springs.

The registration deadline is May 1st, and registration after this date will cost you and extra \$50 late fee. Participants will spend Monday and Tuesday working in the Forest. Every participant will also be given one day for a recreation experience. Choices for recreation may include tubing, fishing, Kennedy Space Center, Orlando Science Center, and Daytona Beach.

Cost for the week which includes food, tenting, recreation, safety gear and patch is only \$195. Space is limited to 300 Arrowmen.

To reserve your place now complete the form on the section website!!

Minimum \$50 deposit required to hold your reservation. Total of \$195 due by May 1, 2010, after that \$50 late fee will be added.

Reservations using a credit card may be processed online or by mail. If paying by check or money order, please use the mail-in form only.

More importantly, I promise you: when you return, the world staring back at you will never seem the same.

Solitude of Crew OAV628B

July 9th, 2006 – Mt. Rose on the shore of Lake Superior

As I sit here on the shoulder of the "Sugar Loaf Mountain," overlooking the expanse of Lake Superior, I look back at the 12 days and 125 miles of toil and hardships it took my Brothers and me to reach this amazing place, a masterpiece of God and nature.

First, our arrival at Northern Tier. We were an oddity to the staff, joking and talking like old friends when in reality we had only known each other for 7 hours. Then came our first decision – one that took us over an hour – what *Voyage* would we embark upon after our week of Service. We bickered and pondered for what seemed like forever until we finally chose – we would go to the Grand Portage and Lake Superior. I believe we chose wisely.

The next day we departed for our worksite, where we would sweat, toil, and bleed for the next week. When we saw and walked through the knee-deep muck, instead of being intimidated by the work to be done, we gladly took the challenge. As I dove headfirst into my work, I began to feel a sense of pride and happiness – one I assume I shared with my Brothers. From hauling rocks twice my weight down a hillside, to breaking rocks into gravel, even to pulling logs out of mud and placing the rocks for the turnpike, I was proud to be doing it not for myself, but for others who will eventually use that trail. The feeling of accomplishment I felt when walking over our completed work was unlike anything I have ever felt. It was so beautiful a feeling I could never describe it with words.

Our first day canoeing – the 4th of July – was a very memorable day. Not only did we paddle 10 miles against a headwind, but we celebrated Independence Day with sparklers. First we celebrated in the U.S., then we jumped the border and danced around Canada with sparklers in our hands and ninja masks on our heads.

Our *Voyage* was a great and unique experience; we even slept under the stars in a blueberry patch one night. We saw waterfalls, bald eagles, moose, loons, and a plethora of mosquitoes and other wildlife. All the lakes, the lunch at Gunflint Lodge, the portages, and the rapids led to the big kahuna – the Grand Portage. We flew through the 8.5 miles with no injuries. Every step I took, I realized that so much history was steeped into that trail that I was honored to be a part of it. I loved every mile of the Grand Portage and I hope each of my Brothers did too. I will miss each and every one of my Brothers and I hope we keep in touch. To both Foremen Brad and Dar, your words of wisdom, your constant encouragement, and countless other things helped us all come together and make it through – I thank you.

So, now in closing I would like to say: OAV628B, fellow Arrowmen, Brothers – thank you all for this experience we have shared and remember: A Scout may be Kick-@\$\$, but he is nothing without Brotherhood and Cheerful Service to keep him going. I now know we chose wisely that night at the map, as I look across Lake Superior's waters, and thank God for all he has done for me.

Election Information

Lodge Officer Election Rules

The following criteria is for the Aal-Pa-Tah Lodge elections which will be used to hold the upcoming Lodge election of Lodge Chief, Lodge Vice-Chief of Inductions, Lodge Vice-Chief of Program, Lodge Vice-Chief of Service, Lodge Secretary, Lodge Treasurer, and Lodge Historian at the upcoming **Ordeal Weekend, June 4-6, 2010**. If you are planning to run for one of these positions, please read the following criteria carefully. The candidates' meeting mentioned under "Candidate Eligibility" item #6 will occur Friday night of the Council's "Scout Fest" at Okeehetee Park in West Palm Beach, Florida on **May 21, 2010**. If you wish to run for office, you must notify the current Lodge Chief at chief@aal-pa-tah237.org AND the Lodge Adviser at 237advisor@arnoldfamily.cc no later than Friday **May 14, 2010**, to schedule your candidate meeting timeslot for May 21, 2010. If you plan on running for office, you also **must** register as an attendee of the Ordeal Weekend and make sure that your dues are current for 2010.

Candidate Eligibility

A candidate for office must meet the following requirements:

1. Must have been inducted or transferred into Aal-Pa-Tah at least six months prior to the election date.
2. Must have dues paid for the current year.
3. Must not reach his 21st birthday during the scheduled term of office.
4. Must physically reside within the official boundaries of The Gulf Stream Council (may be waived at the option of the Lodge Adviser and Staff Adviser).
5. Must be currently registered with a unit that is chartered by The Gulf Stream Council, BSA.
6. Must present himself at the scheduled candidates' meeting unless he is running for a Chapter position or makes specific prior arrangements with the Lodge Chief and/or Lodge Adviser. The candidate may have one person of their choosing with him during the interview. The person can be anyone of the candidate's choosing as long as they are not also a candidate.
7. Must be determined eligible by the Interview Committee.
8. Must provide a letter from his unit leader indicating that a Scoutmaster's Conference has been held to discuss the Scouts role within the unit and how that responsibility will be met during the term of office. Further, that the Candidate has the approval of the unit leader to run for office.

Candidate acknowledges one of the responsibilities of all Officer positions is to meet with the Lodge Adviser and the other officers monthly.

The Interview Committee is composed of The Current Lodge Chief, only if he is not running for an office, The Lodge Adviser, Associate Adviser(s), and one youth, who is not a candidate, which is appointed by The Lodge Chief.

Voter Eligibility

All dues paid members who have not reached their 21st birthday by the day of the election and are registered for the Lodge weekend are entitled to vote. No absentee ballots or proxies are permitted. The Lodge Secretary is responsible to provide the supervisor of elections with an accurate list of eligible voters.

General Election Rules

1. The election for each office is to be held separately. The results will be announced before the next election will begin.
2. A candidate may run for any office. If he is defeated, he may run for another office of his choice.
3. Campaign promotional material is limited to a single poster board. The poster board itself may be science fair project style (with folding sides) or may be just plain poster board and may contain as much information or pictures as the candidate wishes on one side of the board only. There will be no other campaign material by the candidate or on his behalf. All poster boards will be displayed together in a designated location after weekend registration has begun.
4. A candidate may be disqualified, upon the approval of the Lodge Key 3, for violations of the election procedure or for conduct that is not keeping with the highest traditions of The Boy Scouts of America; The Scout Oath, Scout Law and Obligation of our Order will serve as a standard of judgment. A candidate may be held responsible for actions on his behalf.
5. The Lodge Chief and Lodge Adviser shall appoint one youth and one adviser. The youth will hold the title, Supervisor of Elections, and shall hold such duties and responsibilities as are implied by that title and any other duties as may be assigned to him by the Lodge Chief.

At the time of the Annual Lodge Business Meeting, The Candidates will be expected to:

Be nominated by another youth member of the Lodge. The Nominator will be allowed to speak for two minutes on behalf of The Candidate.

Speak for two minutes if they so wish.

Neither the current Lodge Chief (unless he is running), The Supervisor of Elections, nor any adult may nominate, speak for, or in any way publicly endorse any candidate.

8. The Candidate that receives greater than 50% of the votes is elected. Unintelligible ballots are not counted.
9. Unopposed candidates must receive greater than 50% of all votes.
10. In the event of a tie vote, there will be one additional ballot to break the tie. Before the ballot is given, the tied candidates will each be given an additional two minutes to speak on their behalf, if they so wish. If the second ballot results in a tie, the determination of which of the tied candidates will serve in the office is made by the Lodge Executive Committee, before the new officers are installed, and will require a majority vote of that body. Lodge Chief may never be chosen by the Lodge Executive Committee and must be the result of a whole Lodge vote.
11. If no candidate receives greater than 50% of the votes for an office, a second election will be held immediately between the two candidates who received the highest amount of votes. If the second vote results in a tie, the determination of which of the tied candidates will serve in the office is made by the Lodge Executive Committee, before the new officers are installed, and will require a majority vote of that body. The Lodge Chief may never be chosen by the Lodge Executive Committee and must be the result of a whole Lodge vote.
12. If no candidates run for an office, the newly elected Lodge Chief will appoint a Lodge member who meets the candidate eligibility requirements to that office. The Lodge Executive Committee must approve appointments of elected officers.
13. After counting, the ballots will be held by the Supervisor of Elections for a period of thirty days. Any Lodge member, with the approval of the Lodge Chief may review the ballots during this period.
14. New Lodge Officers shall take office on Sunday following the closing of the business meeting. Chapter elections shall take place immediately following Lodge elections.
